**DUE DATE - January 31, 2019 - For Paying First Installment or in Full

Notice is hereby given by the undersigned Town Treasurer of the Town of Kinnickinnic that the tax roll for said Town for the year of 2018 is in my hands for collection and that the taxes charged therein are subject to payment by Mail or at the Town Hall (see hours listed below), on or before January 31, 2019. Real Estate taxes may be paid by installments: First Payment amounts are listed on each tax parcel. Second Payment is due and payable to St. Croix County on or before July 31, 2019. The 2nd half may be paid by Credit Card to St. Croix County for a fee. Any tax payment mailed with a postmark no later than January 31 or July 31 will be considered on time. I will hold office hours in the Town Hall located at 1271 County Rd. J as follows:

Sunday, January 20 - 3 - 5 p.m. Sunday, January 27 - 2 - 5 p.m. or mail payments to the address on the upper left of the tear-off portion of the tax bill.

<u>Note Changes from Previous Years</u>: The days of collection at the Town Hall are Sunday (not Saturday), and there will be no receipts mailed back to residents unless a self-addressed, stamped envelope is included.

***<u>DOG LICENSING (Required Annually by Statute)</u> — Contact the Town Treasurer at 715-425-1180 with questions. A form for obtaining a dog license annually is available to print out from the Town Website:

<u>KinnickinnicTwp.org</u>. The Form is also mailed each December with the Tax Bill(s) for the year. Fees: <u>\$4</u> if neutered/spayed - <u>\$9</u> if not. All dogs must be licensed, 5 months of age or older, or 5 months old within the license year. Proof of Rabies shots must be submitted on purchase of license. <u>See enclosed form.</u> Dates of area Rabies Clinics are published in the newspapers and shoppers. If the tag should get lost throughout the year, please contact the Town Treasurer for a replacement tag.
