## Town of Kinnickinnic Resolution # 2009-9

A Resolution modifying speed limits on all Town Roads as located within the boundaries of the Town of Kinnickinnic.

WHEREAS, the Town Board of the Town of Kinnickinnic has jurisdiction over those portions of town roads as located in said Town; and

WHEREAS, the Town Board of the Town of Kinnickinnic has determined under §349.11 (1) (a), Stats., that the statutory speed limit on said road (55mph) is greater than is reasonable or safe under the conditions found to exists upon said highways;
