TOWN OF KINNICKINNIC
MANUFACTURED HOME MOVING PERMIT ORDINANCE

An addendum to the 2010-1A Building Ordinance

WHEREAS, the Town Board of the Town of Kinnickinnic adopted Ordinance 2010-1A on April 5, 2010 and Ordinance 2010-2 on September 7, 2010, pursuant to Section 66.0103 Wis. Stats.

NOW THEREFORE, the Town Board of the Town of Kinnickinnic does hereby ordain as follows:

SECTION 1: When moving a manufactured home into the Town of Kinnickinnic ,approved State and County permits are required, no additional moving permits are required from the Town of Kinnickinnic.

SECTION 2: NONEXCLUSIVITY:

A. Other Ordinance

- a. Adoption of this ordinance does not preclude the Town Board from adopting any other ordinance or providing for the enforcement of any other law, ordinance of forfeiture related to the same or any other matter.


SECTION 3: SEVERABILITY: If any provision of this ordinance is held to be invalid or unconstitutional by a court, or if the application of this ordinance to any person or circumstance is held to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity and those provisions of this ordinance which can be given effect without applying or enforcing the invalid or unconstitutional provision.

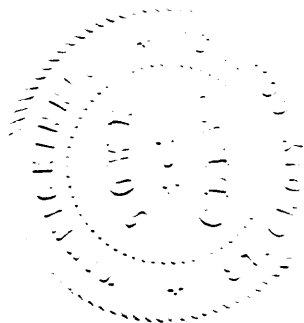
SECTION 4: EFFECTIVE DATE: This ordinance shall take effect upon its passage and publication as provided by law.

TOWN OF HANSHAWICK
PARTIAL RECORD FOR THE YEAR 1989

An official record of the Town of Hanshawick, Delaware.

WHEREAS, the Town Board of the Town of Hanshawick, Delaware, on the 15th day of June, 1989, adopted Ordinance 88-03 on Resolution 7 & 10, for the purpose of amending the Charter of the Town of Hanshawick, Delaware, to read as follows:

SECTION 1. The Board of the Town of Hanshawick, Delaware, hereby ordains that the following provisions shall be added to the Charter of the Town of Hanshawick, Delaware:

SECTION 2. When moving a residential lot into the Town of Hanshawick, Delaware, the lot owner shall be required to provide a site plan showing the location of the lot and any other structures on the lot, and the lot shall be subject to the provisions of the Charter of the Town of Hanshawick, Delaware.

SECTION 3. The Board of the Town of Hanshawick, Delaware, hereby ordains that the following provisions shall be added to the Charter of the Town of Hanshawick, Delaware:



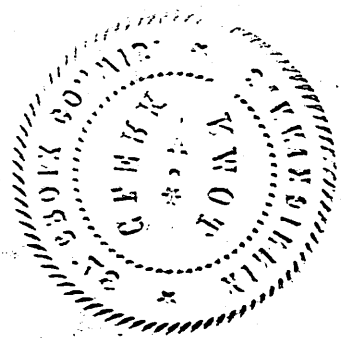


